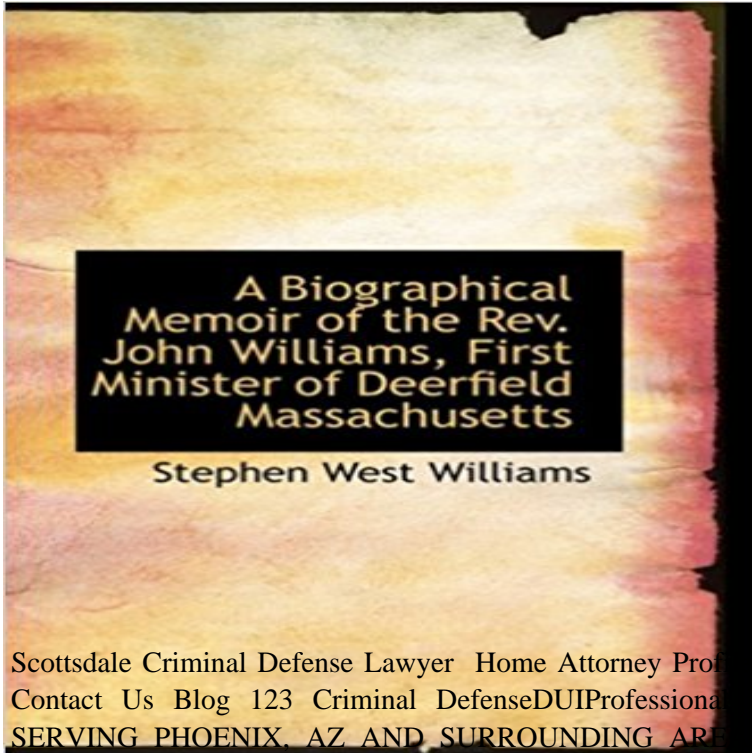


# A Biographical Memoir of the Rev. John Williams, First Minister of Deerfield Massachusetts
