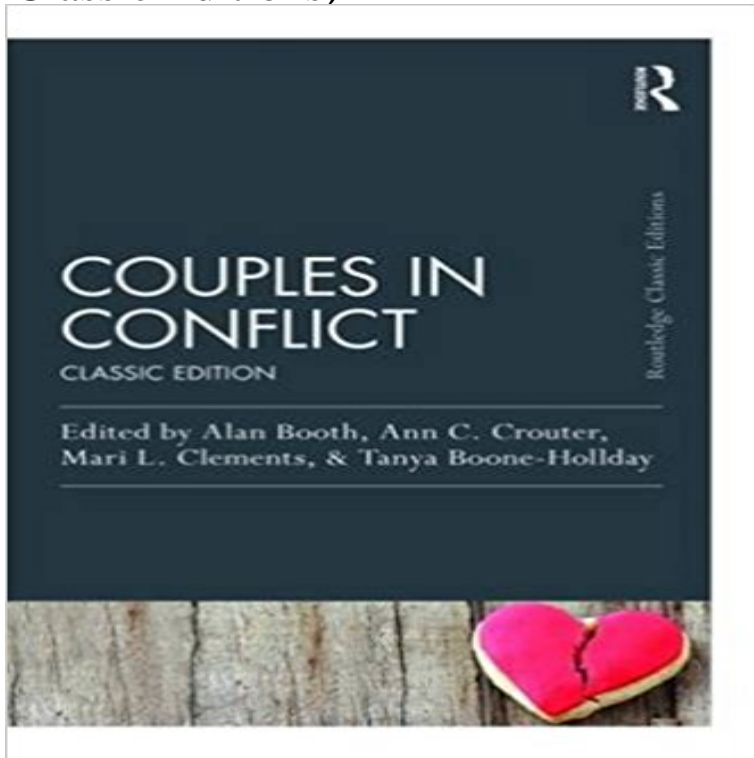


# Couples in Conflict: Classic Edition (Psychology Press & Routledge Classic Editions)
