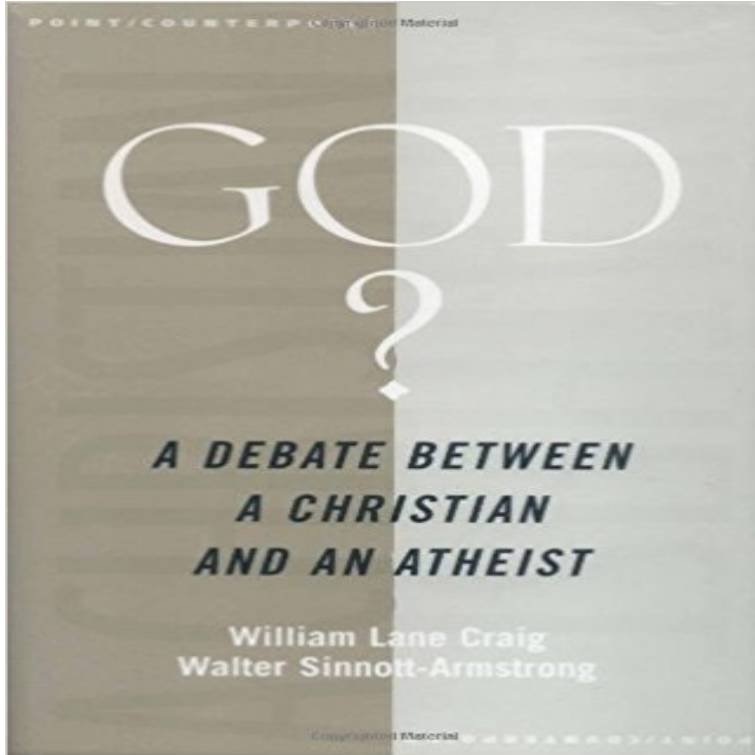


# God?: A Debate between a Christian and an Atheist (Point/Counterpoint)
