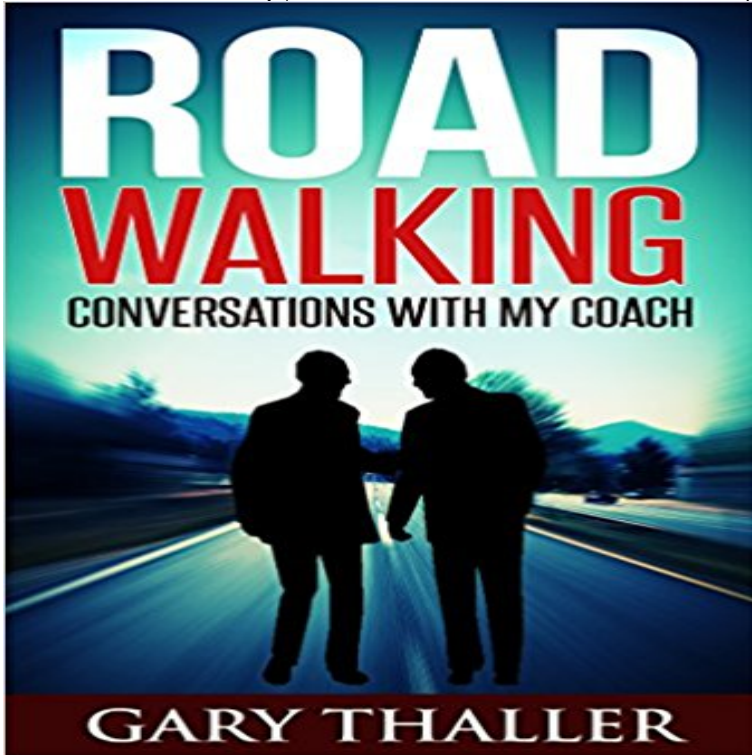


Road Walking: Conversations with my Coach
