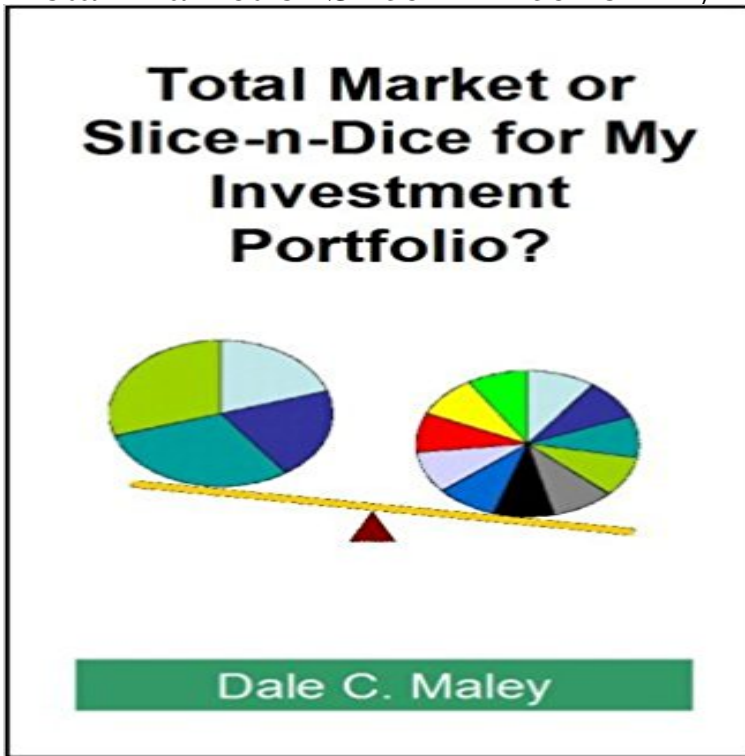


Total Market or Slice-n-Dice for My Investment Portfolio?
