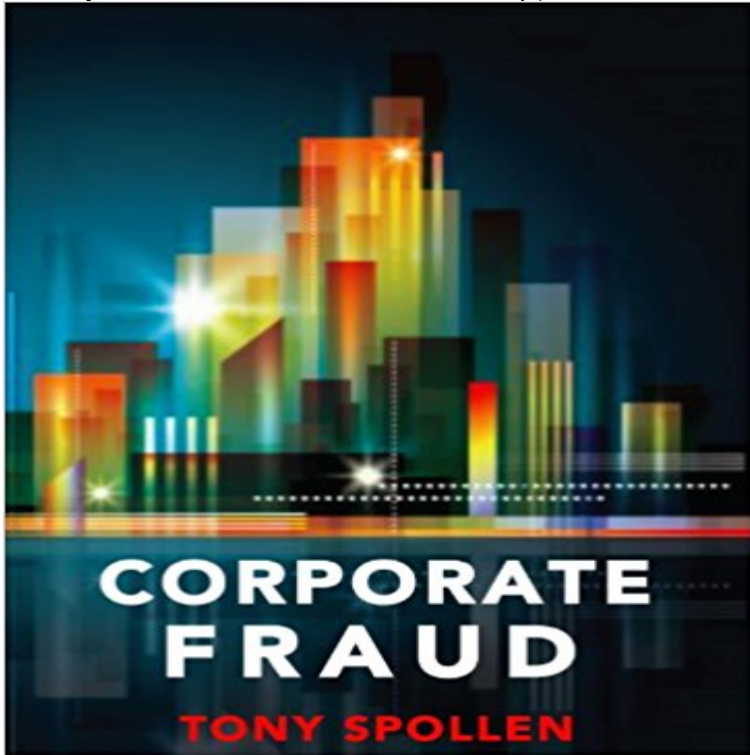


Corporate Fraud: The Danger Within
