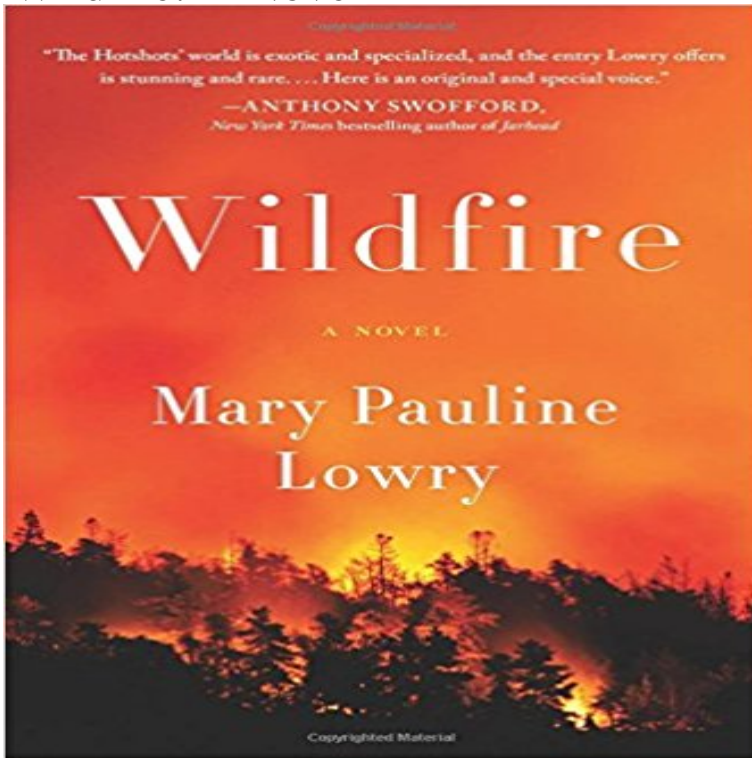


# Wildfire: A Novel
