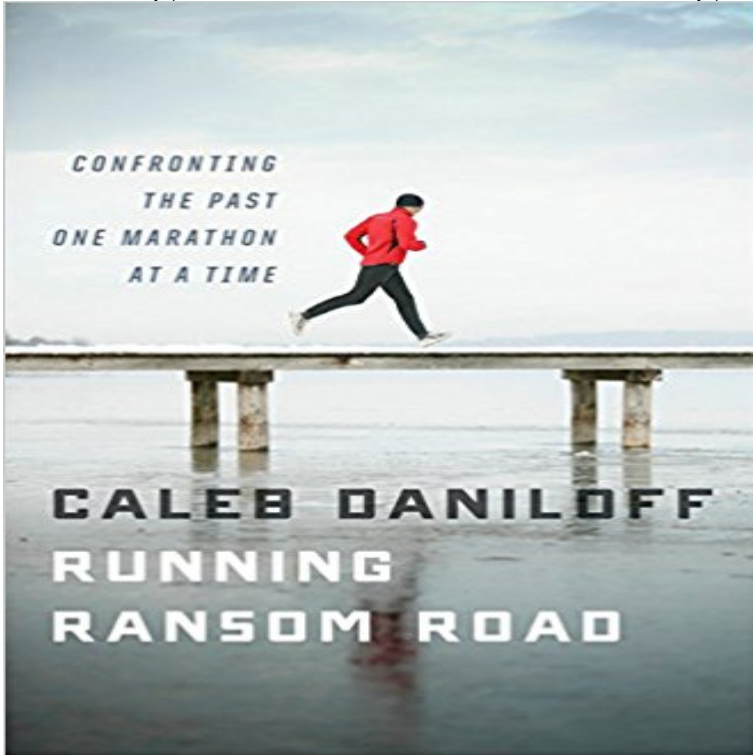


# Running Ransom Road: Confronting the Past, One Marathon at a Time
