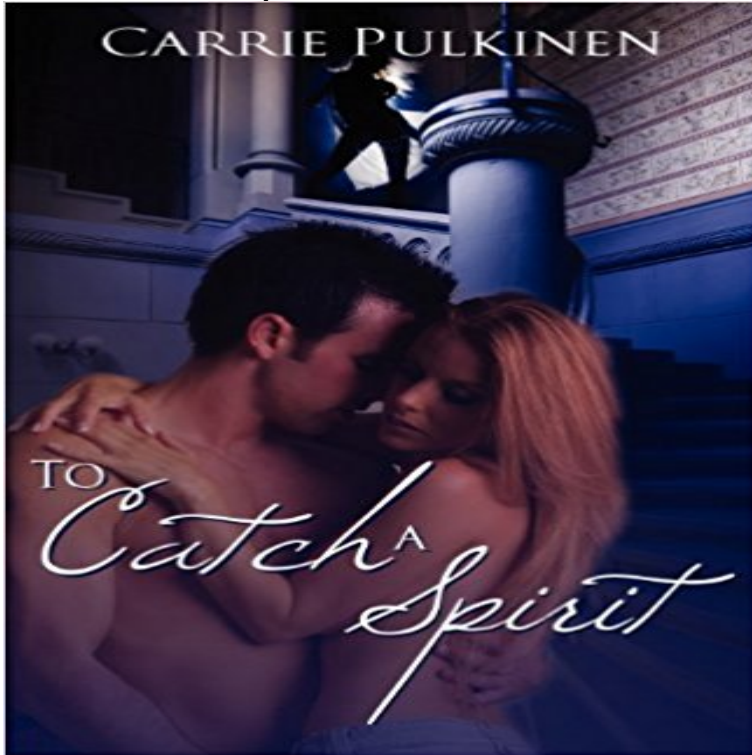


## To Catch a Spirit
