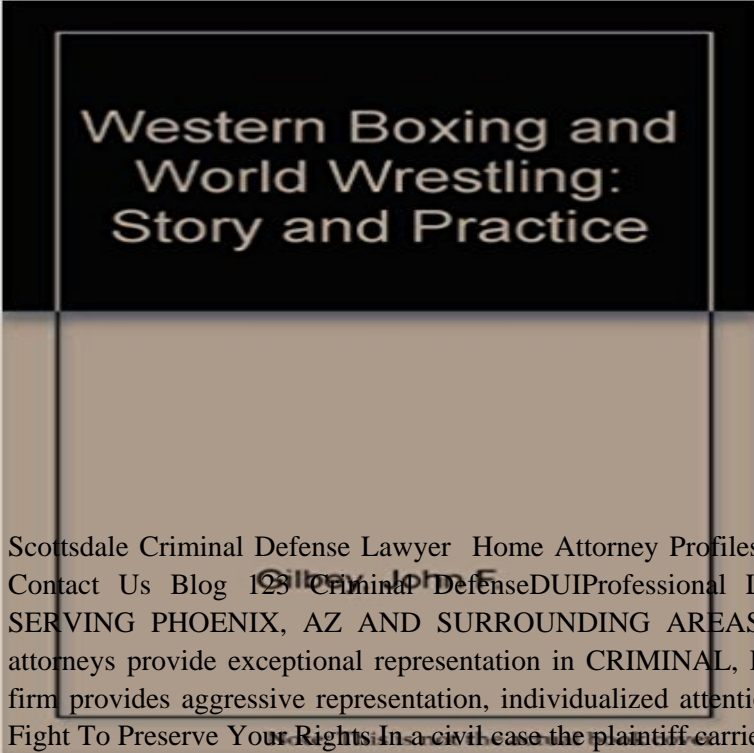


Western Boxing and World Wrestling: Story and Practice
