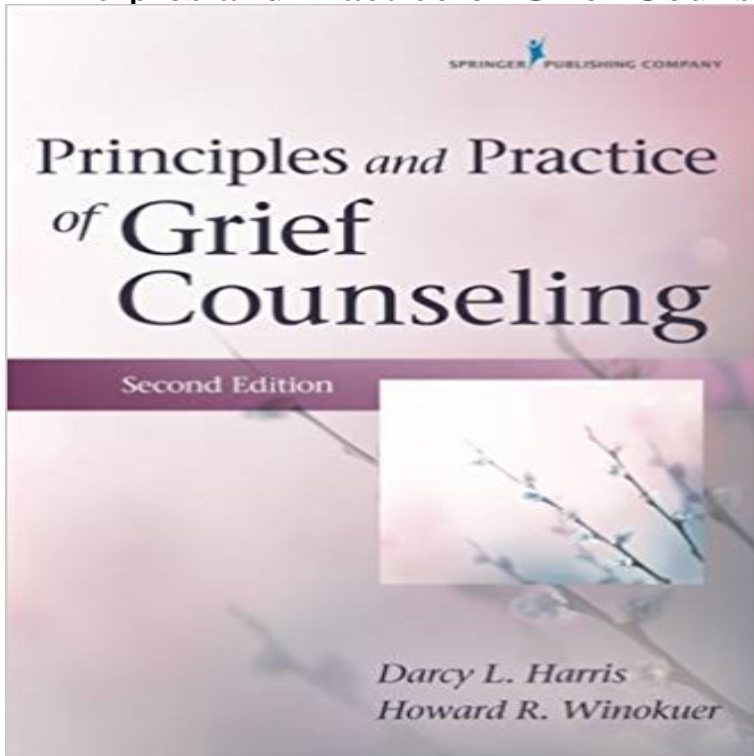


# Principles and Practice of Grief Counseling, Second Edition

It discusses the implications of the DSM-5s omission of the bereavement exclusion for the diagnosis of a major depressive disorder. A completely new chapter on the social context of loss addresses social messages, grieving rules, workplace policies, and the disenfranchisement of many aspects of normal, healthy grief. New case scenarios further enrich the second edition. The text describes the unique aspects of grief as a normal response to losses, both death- and nonvdeath-related, and views the goal of counseling bereaved individuals as one of facilitating the unfolding of the healthy and adaptive aspects of the process as it manifests itself within each client. Specific counseling practices that facilitate successful interventions are discussed, particularly that of presence, considered by the authors to be the primary therapeutic stance when working with bereaved individuals.
