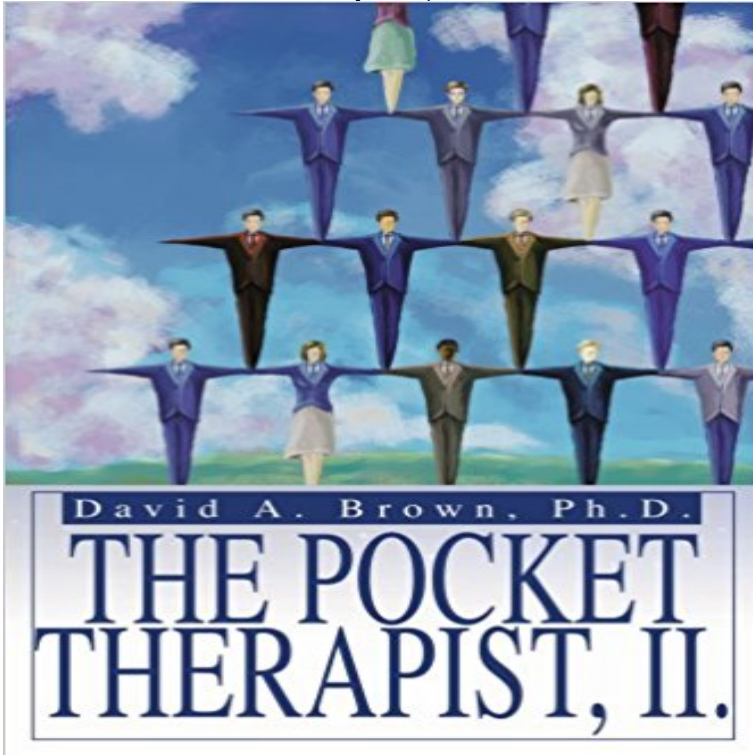


## The Pocket Therapist, II.
