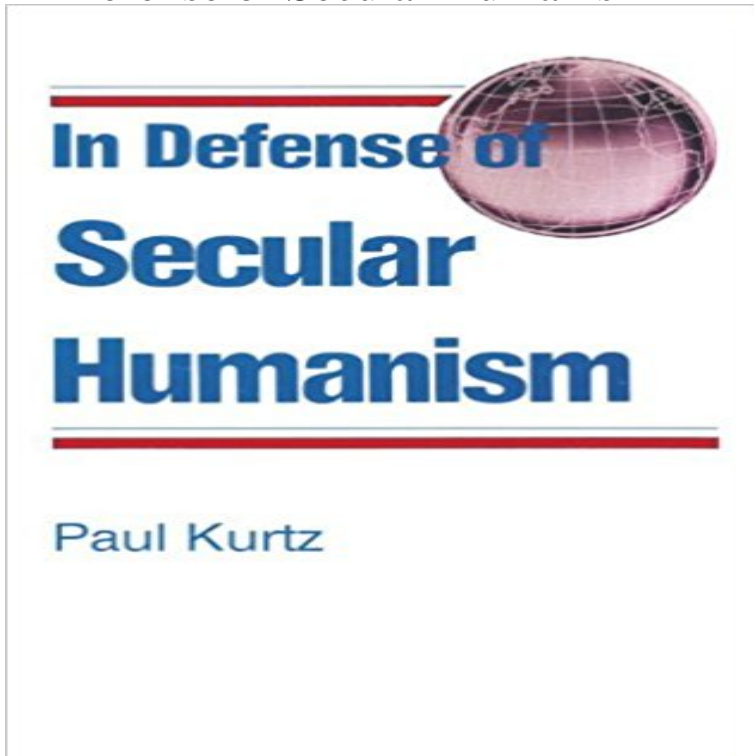


In Defense of Secular Humanism
