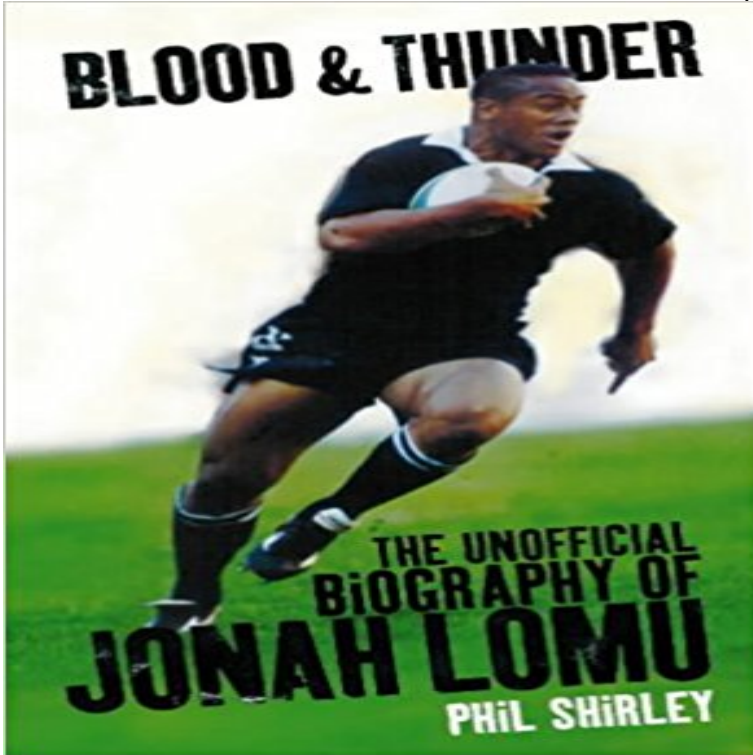


# Blood & Thunder: The Unofficial Biography of Jonah Lomu
