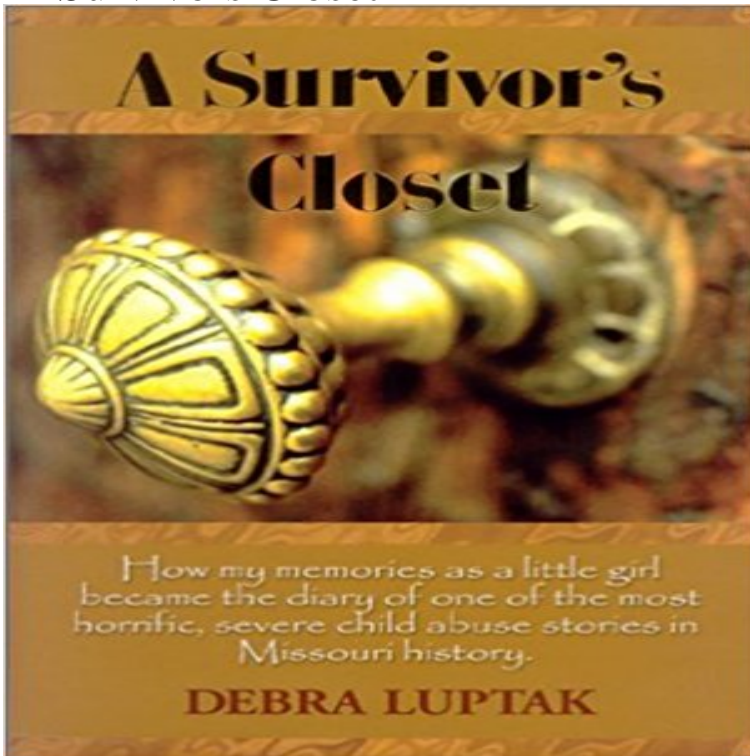


## A Survivors Closet
